Government Executive Agencies are established to perform government executive functions which are delegated to them. This by no means makes such functions less governmental and ought to be taken as such, when they are executed.

This framework document is a customised legal framework for the Business Registrations and Licensing Agencies (BRELA). The document derives its authority from the Executive Agencies Act No. 30 of 1997 together with its Regulations. This document therefore, clearly specifies the functions that the Minister for Industry and Commerce delegates to BRELA, the extend of responsibilities and the roles of all the players in the setting up, launching and finally, operating processes of this Agency. The document specifies also the role of the Minister, the responsibilities of the Permanent Secretary, the Chief Executive and those of the Ministerial Advisory Board.

This document further delineates how BRELA is politically and publicly accountable particularly on matters relating to its day to day business, the standards of performance and the management of public funds.

The Government through this framework document undertakes to grant the necessary freedoms and flexibilities to enable the Agency perform and operate in a business like manner to enable it achieve its strategic plans. The Government will, nonetheless use the available monitoring controls to ensure that the agency is always on track.
